he had time for our children and me Over the East ten years J. J. has been especially helpful and considerate while I cared for my elderly parents. My father had been bedridden for many years and my nother, who suffered from algheimers, endured many operations and convelescence for breast cancer, heart value replacement and hip replacement. although my parents needed my constant attention my husband never complained. Jay fell souful that while he was incarcerated my mother had been suddenly hospitalized and past away the day he was released. For the first time in his life he wasn't able to be there when the guls and I reeded He has instilled in his two doughters, by his own example, a work ethic that has enabled them to establish their own self worth and self esteem. as a father he has proudly observed both Renée and Copsi I grow into kind, warm hearted, productive and community mended young woman. Jay is a hardworking and dedicated familyman who has earned the love and respect of his children family and friends. Phil and I have delivered stoves and washers, pots and pans and dishes. One grandmother said as the family was unpacking their gifts, "New plates, now we can all eat together". This family hardly had any dinnerware and was forced to eat in shifts. Last year we purchased and had a plumber install a new commode for our Christmas family.

In addition each family receives hundreds of dollars in clothing certificates, personal gifts for every member, a Christmas tree and decorations if needed, bags of groceries including a complete Christmas dinner. Everything from the salt and pepper to a full sized turkey and all the ingredients for a festive holiday meal.

A very small team has handled all of this. Phil Welce, with the aid of the Shrine drivers that transport the children to the Erie hospital, recommend a family in need and the family provides their wish list. I price and shop for the items. Phil and the Shriners, with help from Santa, deliver the gifts. Mr. Cafaro pays for it all at a cost of thousands of dollars each year from his personal funds. I estimate that Mr. Cafaro has donated in excess of \$120,000.00 in the more than 30 Holiday Seasons.

The most rewarding part is that Mr. Cafaro, the Shriners and I have been doing this for at least 30 years without publicity. This is a very important part of this entire project. It is that "something special" that we do for someone, personally and privately, without fanfare. It is our wish that it continue to remain a private gesture of one human being helping another.

J.J., as I know him, has shown me time and again that he is a caring person. He has expressed that both in thought and deed. We have spent many hours talking of the community, the people and the needs of both. He has in an unselfish way shown his desire to help others. Not to receive plaudits and pats on the back, but rather a satisfaction that he has been able to share some of his good fortune in a meaningful way.

Please, Your Honor, may I ask you to consider this letter as just one example of Mr. Cafaro's true character.

Approximately thirty years ago, I received a call from Mr. Peter Gabriel asking if the Youngstown Shrine Club had any Shrine patients with a family that was in need of Christmas gifts. Mr. Gabriel related that he had been contacted by an anonymous benefactor who would like to make Christmas a joyous event for someone, who, otherwise, would not have a happy holiday.

I informed Mr. Gabriel that we had many shrine families in the Mahoning, Trumbull and Columbiana Counties that were almost destitute, and would be overjoyed to receive anything. I was one of the several transportation drivers of the Club at that time, and still am, which provides free transportation to children and their parents to the Erie and Cincinnati Shrine Hospitals for free treatment of orthopedic and burn injuries. The transportation drivers then had a meeting to select the most worthwhile family, as we had been in the homes of the patients and knew them somewhat personally.

We assumed this would be a one-time occurrence, but that has not been the case. J.J. has continued his giving every single year, and each year a different family is chosen to be the recipient. These families have always been unknown to J.J.

Mr. Cafaro does not just send a turkey or a ham and a box of candy. The family is asked what they would like to have or need, this includes every member living in the home. Each person makes out their Christmas list, and the items are then purchased for

each individual by Mr. Gabriel. Beds, for children often sleeping on the floor, pots, pans, food, appliances, clothes, furniture, Christmas trees, toys, games, and much more, are all given through the generosity of J.J. Transporting van drivers, their ladies, myself and my wife, Rita, deliver these gifts a few days before Christmas each year.

Honorable Judge Adams, this is what Christmas is all about. The families cry and give us all hugs, and we cry, also, as we leave their homes. They never, ever expected all that was delivered to them. Many are still in shock as we go out the door shouting "Merry Christmas."

The very next day, J.J. calls to see exactly how the Christmas visit went, and if they are in need of anything else. This is true character in a gentleman that cares about others.

I would just like to relate one success story whereupon a young lady with spina bifida asked for a computer and nothing else the year she and her family were chosen. Today, because of that one gift from Mr. Cafaro, she is a graduate of Westminster and Dartmouth Colleges with a Masters degree in neuro science and a doctorate in psychology and then continued her education to become a successful neurosurgeon in a pediatric hospital. She visits her family in the area a few times a year and never fails to contact us to let us know that without that gift of the computer she would not have gone on with her education to become what she is today.

Eventually, I did have the privilege of meeting J.J. Cafaro, but even to this day, he wants to remain unknown as far as all of his generosity is concerned, but these many families he has blessed over the years, with his bounteous giving, will always remember, there really is a Santa Claus.

I have been a Shriner for over 30 years, serving as Transportation Chairman for the Youngstown Shrine Club, becoming its President in 1993. In 2002, I was elected to be the Illustrious Potentate of Al Koran Shrine in Cleveland, Ohio, which gave me jurisdiction over 52 shrine clubs and units across the State of Ohio. I served on the Board of Governors at the Cincinnati Shrine Hospital for ten years, becoming an emeritus member in 2008.

My name is Joseph Lordi, and i am the C.E.O. of Gleaners Food Bank in Youngstown, Ohio.

Gleaners food bank was conceived and opened for business in 1985, giving food and clothing to underpriviledged families and, in particular, children and the elderly. Since 1985, GLEANERS has supported hundreds of thousands of families in the greater metropolitan area of Youngstown, Ohio and adjascent counties. GLEANERS is unique in that it operates without a single dollar of taxpayer monies, relying soley on private donations for food, clothing and labor, for its constituents. It is a total voluntary effort of love directed to our fellow man.

GLEANERS began and still operates on the premise of obtaining food from local stores and food storage centers, picking up same with the use of a fleet of semi-tractor trailors that travel all over the midwest to retrieve the food and clothing supplies and store them in our large facility on pyatt street in Youngstown, Ohio.

The success of GLEANERS would not have been
