On 06/11/12 at 2008 hrs I, Sergeant Saluga, was dispatched with Lieutenant Grahovac to the Sun Merchant for a fight involving a stabbing. While on the way dispatch advised that all involved parties had fled the scene.

Upon arrival I spoke to Earl R. McGowan (witness) who stated he was alerted by customers that there was a fight in the parking lot. McGowan stated he ran outside and told the males to stop fighting or he was calling the police. McGowan said he then stepped between the two males and forced them apart. McGowan said one male entered a silver Jeep with Ohio registration FAE 5375 and the vehicle left south bound on S. Meridian Rd. with a female occupant. McGowan advised the other male was bleeding from two puncture wounds to his lower left back. McGowan said the second male insisted on driving to the hospital and left east bound on Mahoning Ave. in a black Buick with a female occupant.

At 2027 hrs dispatch advised that a male was at St. Elizabeth's Hospital in Austintown with stab wounds to his back. Upon arrival I spoke to Paul D. Jones (present) who confirmed he was involved in the incident at the Sun Merchant. Jones stated he was east bound on Mahoning Ave. near Four Mile Run Rd. when a silver Jeep tried to cut him off. Jones said he sped up and the vehicle pulled beside him. Jones said the driver was yelling out the window and telling him to pull over. Jones said he pulled into the Sun Merchant, as did the Silver Jeep, and exited his vehicle to meet the driver. Jones advised the argument became physical and his girlfriend, Carolyn J. Tuchek (present) tried to break it up. Jones stated the driver threw Tuchek to the ground and they continued to fight until the store clerk (McGowan) separated them. Jones said the driver entered the silver Jeep and fled south bound on S. Meridian Rd. Jones advised he took a picture of the Jeep and the license plate with his phone. Jones then left the scene, went home and then to the hospital. I took photographs of the 2 puncture wounds to Jones's back, a scratch on his back and a scratch on his left arm.

I also spoke to Tuchek who confirmed Jones's story and advised she was struck in the right ear by the driver of the silver Jeep knocking two of her earrings out. I took pictures of Tuchek's ear.

The Ohio registration FAE 5375 returns to a silver 2008 Jeep to John T. Dellick of 7936 Spring Lake Ln. in Canfield. Dispatch requested an MCSO unit go to the address and have the registered owner contact APD. I received a telephone call from Dellick who stated the vehicle was being driven by his son, John T. Dellick (present). Dellick stated that he was on his way to St. Elizabeth's in Boardman due to his son being stabbed. I then went to St. Elizabeth's in Boardman and spoke to Dellick. Dellick refused to complete a statement, answer questions or identify the female in his vehicle. I took pictures of Dellick's black left eye, a scratch under his nose and a cut to his left hand.
