STATE'S NOTICE OF INTENTION TO USE EVIDENCE IN THE FORM OF RECORDINGS

Now comes the State of Ohio by and through its attorney, Timothy J. McGinty, the Cuyahoga County Prosecutor, and does hereby respectfully provides the defendants with its Notice of Intent to Use Evidence of recordings in the Form of Recordings as agreed upon by the parties on September 15, 2014 and as ordered by this Court. The State will further submit to this Court an Additional Notice of Intention to Use Evidence in the Form of Documents in accordance with the defendants' request.

The State has agreed to partially lift the "counsel only" restriction placed on some of the evidence so that defense counsel may share such evidence/discovery with the defendants ONLY. This relaxation of the counsel only designation does not extend beyond the defendants themselves.

The State possesses approximately 700 hours of audio recordings made by more than one informant. There are not, nor does the State possess, 2,000 hours of recordings. The recordings are in the form of recorded phone calls and recorded person-to-person meetings. The following is a list of recordings the State may use as evidence during the trial of this matter as recorded by Confidential Human Source 1. It is important to note that these are not all of the recordings that the State has provided to the defense in discovery. To aid defense counsel in their understanding of the evidence, the State has provided the date and location of each recording below as follows:
