
The Waiver is made without threat or promise or hope of leniency and is my free and voluntary act.

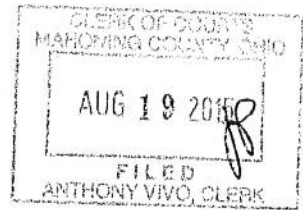

COUNT ONE
