INCIDENT NUMBER

On 10-14-15 at 1830 hours, Brian A. Bailing arrived at Post 1 to file a felonious assault report against Kelly R. Pavlik. Brian stated on Aug 9th he was at 3692 Sugarbush digging a lake. This incident was being videotaped by Brent Furry on a cell phone and later sent to Brian via group text. Brian said the whole group watched this incident occur and laughed. Brian went to St. Elizabeth's Main on Monday Aug 10th. Brian has the video and pictures on his iPhone. He voluntarily turned over his cell phone to the Sheriff's office for evidence.
