NARRATIVE

On the above date and time, Suspect 1's vehicle exited the Tallmadge Circle onto North Ave without using a turn signal. The occupants were asked to step out and were searched. They were placed in the rear of car 4 without handcuffs. The vehicle was searched and marijuana shake was observed on the driver's seat. Officers also located a loaded handgun inside the glove compartment. Suspect 1 was read his Miranda Rights and asked about the gun. Suspect 1 admitted to knowing the gun was inside the vehicle, but was not his. He stated the gun was not the passengers. Suspect 1 was placed under arrest for CCW and Improper Handling. He was booked at Tallmadge PD and then transported to Summit County Jail. Phil's Towing did impound the vehicle. The passenger was given a ride to his destination.
