



Now comes DET. TONY VILLANUEVA OF THE HOWLAND TOWNSHIP POLICE DEPARTMENT, hereinafter referred to as Affiant, who first being duly sworn according to law deposes and says:

1. Now comes the Howland Township Police Departments Detective Tony Villanueva, hereinafter referred to as the Affiant, who first being duly sworn according to law deposes and says:
2. Affiant Villanueva has been a police officer since 2005. Affiant Villanueva has been employed by the Howland Township Police Department since July 2008. The Affiant's prior police experience includes 5 years as a Narcotics Agent with the Trumbull Ashtabula Group (TAG) Law Enforcement Task Force and 3 years with the McDonald Village Police Department where Affiant conducted Drug and Criminal Investigations. Affiant Villanueva worked in the Patrol Division with the Howland Police Department from 2008 through 2010 until being assigned to the Detective Division with the Howland Township Police Department. Affiant is currently assigned to the Trumbull County

Homicide Task Force since 2015. Affiant has undergone extensive training in law enforcement, to wit: Ohio Peace Officer Training Academy, DEA Basic Narcotics Training, Master Investigator Certification, Undercover Investigations, Undercover Survival and Lawful Evasions, Electronic Surveillance, Core Criminal Investigation Training, Human Trafficking, Blood Stain Evidence, Internet Investigations, Cell Phone Analysis, Photography For Investigations, Patrol Techniques, Hazmat Training, and numerous other Law Enforcement training classes. Your Affiant has been involved in several undercover operations involving surveillance and narcotics purchases which have led to the arrest of individuals involved and the illegal narcotic trafficking business. Your Affiant has been involved in several homicide, burglary, theft, prostitution and identity theft cases which have led to the arrest of individuals.

3. On February 25th 2017, Officers with the Howland Township Police Department responded to 1564 Niles Cortland Road, Warren Ohio, Howland Township, Trumbull County, Ohio at approximately 4:23 p.m. in reference to shots being fired. Subsequently it was determined that five (5) people were shot at that location. Two (2) individuals have died as a result of being shot. The deceased are Joshua Haber and Joshua Williams. The three (3) survivors as of the date and time of this affidavit are April Vokes, John Shivley and Bryce Hendrickson. Haber was declared dead at the scene (in the van) Williams died at St. Elizabeth's hospital after being transported from the scene. Vokes was shot numerous times including the head, arms, chest and legs and was in the driver's seat of the van. Vokes remains hospitalized. Hendrickson was shot in the face and in the arm. Shivley was shot in the back. A gold minivan with Florida license plates was partially on

Hamad's driveway and property just off of Niles Cortland Road (State Route 46). This is the vehicle the victims were shot in and it had numerous bullet holes in it.

4. Responding officers also observed Nasser Hamad near the front entrance with a firearm in his hand. Hamad walked into the house and came out of the house with his hands up and without the firearm. Also in the home was Tracy Hendrickson. Affiant has learned that the home located at 1564 Niles Cortland, Warren, Howland Township, Trumbull County, Ohio is owned by Hamad. According to information Hamad has a relationship with Tracy Hendrickson.
5. Hamad eventually came out of the residence with his hands up. Officers secured Hamad and found a 9mm handgun.
6. As Officer Bryan Butto was escorting Hamad to a Howland Police Cruiser they walked past Bryce Hendrickson who had been shot by Hamad. Hamad shouted "that's what you get you little bitch." "how do you like that".
7. Tracy Hendrickson has a son named Bryce Hendrickson. Bryce has a Facebook account under the name of "Joaquin Guzman" according to information provided by John Shively. Affiant has observed Facebook conversation between Bryce Hendrickson (using the "Joaquin Guzman" name) and Nasser Hamad. The conversation has been saved by Affiant and essentially boils down to threats made by both parties.
8. Affiant screen saved the conversation. There was a discussion about Bryce's mother, the girlfriend of Hamad. Bryce "Joaquin Guzman" stated "my mom was dissing the fuck outta you too bruh" Hamad replied "Show me white boy pull it up". Hamad stated "your mom one of many broads that love me..." & "U beat your mom" Bryce "Joaquin

Guzman" replied "Nahhhh she don't love you". Then the conversation turned to allegations that Hamad stole things from Bryce "Joaquin Guzman". There was discussion about fighting each other. Bryce "Joaquin Guzman" stated "He aint worth the time fr" Hamad stated "U a pussy bitch two.. Come try to rob me druggie.. I got boys in Miami and all the way north on 95..look u up too pussy bitch." John Shively joined the conversation and stated "Nasser Hamad what's your address" and "Nasser Hamad you still talkin I just want your adress" Hamad replies "1564 nils cortland bitch. Are u smart enough to figure city" Then Hamad stated "All of u and still know one showing up u fucking pussys" Hamad stated "U all pussys and type like pussy bitches.. Action motherfuckers where is it" Hamad states "Yea I heard but u not coming even with your gang" John Shively stated "Nasser Hamad I'm comin" Hamad states "In that goofy car grandpa bought loser" Bryce "Joaquin Guzman" states "Scoop me" Hamad replies "Hurry the fuck up u pussy bitch and beep horn pussy" and Hamad stays "Scoop the other little dicks too" Hamad states "I waiting and blind open.. I never call 911 dont worry!!!" Hamad stated "Come u pussys"

9. Affiant has obtained a recorded statement from Nasser Hamad after Hamad was read and waived his Miranda Warnings. Hamad admitted to a conversation on Facebook with Bryce Hendrickson and Hendrickson's friends joined the conversation. Hamad stated that he was tired of the conversation and argument and told them to come over and posted his address in the conversation. He told them to beep when they got there. Prior to the victims of the shooting arriving at Hamad's home a vehicle that had arrived at the residence to conduct business with Hamad arrived. Hamad stated he thought this vehicle

was Bryce Hendrickson and his friends arriving to fight. This vehicle and the occupants were only there to purchase landscaping boulders.

10. Eventually the gold van with Florida license plates arrived. All five occupants exited and a fist fight ensued between Hamad and John Shively a 17 year old male. Hamad according to his statement and witnesses came out of his house to fight. Eventually the other three males exited the van. The fight ended and the five individuals from the van then returned to the van which was parked near the apex of the driveway and State Route 46.
11. In Hamad's statement to Affiant and according to the surviving witnesses Hamad went into his house. Hamad stated to affiant he grabbed a 9mm handgun from his bedroom. He then exited his house. According to Hamad he stated, "I just shot them. I got tired of this shit, they been fucking with me for a long time and they shouldn't have come over." According to Hamad and witnesses he unloaded the entire magazine from the firearm. According to both Hamad and witnesses Hamad walked from his front porch to the passenger side of the van shooting the gun. According to Bryce Hendrickson Hamad put the gun in the passenger side window and fired numerous times at the occupants of the van. According to Hamad no one came into his home at any point. Hamad stated to affiant that he "went to hold them." "they needed to pay." Hamad did say that he observed a knife but didn't see a gun.
12. After unloading the gun and according to Hamad and witnesses Hamad went back into his residence and obtained another magazine for his 9mm handgun. Hamad told Affiant that the second magazine was on a kitchen table in the house. Hamad then came back out




of the house and as he approached the van an off duty EMT individual had pulled into Hamad's driveway after seeing what he initially believed to be a car wreck. The EMT in a recorded statement told investigators that he observed an individual bleeding from his mouth and appeared to possibly have been involved in a car wreck. As the EMT exited his vehicle and grabbed his medical bag he observed a male approaching the van. He described the male as wearing clothes consistent with the clothes Hamad was wearing. The EMT then stated he asked the man walking from the house to the van "what happened?" The EMT stated the individual stated "I'll show you what happened" and as he said this the EMT saw the individual reach between his legs and appeared to be racking a round into a gun or unjamming a gun. The individual then shot into the passenger side of the van towards the female driver. The EMT then got back into his truck. The EMT then said he observed a male wearing pajama pants standing face to face with the shooter right in front of the sliding door of the van. The EMT heard the man in pajama pants say you shot my mom motherfucker. The two men did not engage in any physical confrontation at that point. The man with the gun then pointed it at the man in the pajama pants. The man in the pajama pants turned and tried to get into the van. The individual with the gun then fired three times. The EMT drove his truck down the driveway and parked it and ran from the scene.

13. As Hamad was shooting into the van the second time John Shively and Bryce Hendrickson fled from the van and ran. Shively ran south down the west side of Niles Cortland Road (State Route 46) and Hendrickson ran eastbound across all five lanes of Niles Cortland Road (State Route 46). Affiant is aware that this area is heavily traveled


and based upon video obtained in this investigation numerous vehicles were traveling down the road at the time of the shooting. Hamad admitted to Affiant that he shot at both of Shively and Hendrickson as they were running away.

THEREFORE for the above given reasons, Affiant firmly believes he has shown that probable cause has been established to charge the following person: NASSER Y. HAMAD, DOB 4/14/69, [REDACTED] with the crimes of AGGRAVATED MURDER (2 COUNTS) in violation of section 2903.01 (A) & (F) of the Ohio Revised Code and ATTEMPTED MURDER (3 COUNTS) in violation of section 2903.02(A)&(D) & 2923.02(A)&(E)(1) of the Ohio Revised Code, and after due consideration, Affiant further prays that this Honorable Court issue upon the Prosecutor's Complaint a warrant for the arrest of said NASSER Y. HAMAD, DOB 4/14/69, [REDACTED]
