On the above date and time Gerald Hockey arrived on station and requested to file a report on behalf of his girlfriend, that was bitten multiple times by two dogs while at work. Gerald advised that his girlfriend was unable to come in herself due to the numerous injuries she received.

Gerald advised that his girlfriend Veronica Williams works at the Hubbard Pet Resort on W. Liberty St. He stated that his girlfriend advised him the following; at approximately 07:40 hrs. she was on the second floor and was leaving two dogs out of their suite or caged area. Veronica let out Zeke a 50 pound tan pit bull DOB (05-15-15) and Lexi a 45 pound brindle boxer pit DOB (04-21-17) both dogs have the same owner and arrived together to the pet resort. When she let the dogs out they both started to run down the hallway, then turned around and the pit bull came running at her and jumped up biting a chunk of flesh from her left side of her cheek. The dog continued to bite her upper right arm taking a chunk of flesh out, bit elbow area and left forearm. While she was being attacked by the pit bull she was also being attacked by the boxer pit. The boxer pit bit puncture wounds on both of Veronica's thighs and both shins inside and outside along with numerous bruises. While this incident was taking place Veronica was screaming for help from the staff. Shortly after a female employee Asten helped get the dogs off of her and get them put away.

After the incident the staff called Gerald to come to the pet resort in reference to his girlfriend being bit. On his arrival he found his girlfriend sitting down shaking with blood dripping from her face, with towels wrapped around her arms. Gerald then inquired as to why an ambulance was never called for her. He then stated he got Veronica into the car and drove her to St. Elizabeth's hospital for medical treatment.

Gerald stated that the Hubbard Pet Resort requires all animals kenneled to have all their necessary shots. The two dogs that bit Veronica go to the Parkman Rd. Vet Clinic (330) 898-1856. He further advised that the owners of the dogs are Samantha and Joseph Sirna of Vienna.

Gerald stated that the Hubbard Pet Resort immediately called the pet owners to come pick up their dogs and advised them that the dogs, were not welcome back to the facility.

This Officer will foward a copy of the report along with pictures to the Board of Health and the Trumbull County Dog Warden.
