THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 16th day of December, 2018, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, by force, stealth, or deception, did trespass, as defined in Section 2911.21(A)(1) of the Revised Code, in an unoccupied structure, with purpose to commit therein any theft offense, as defined in Section 2913.01 of the Revised Code, or any felony, to-wit: the Matthews High School,

in violation of the Ohio Revised Code, Title 29, Section 2911.13(A)&(C), and against the peace and dignity of the State of Ohio.



COUNT 2: BREAKING AND ENTERING (F5)

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 28th day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, by force, stealth, or deception, did trespass, as defined in Section 2911.21(A)(1) of the Revised Code, in an unoccupied structure, with purpose to commit therein any theft offense, as defined in Section 2913.01 of the Revised Code, or any felony, to-wit: the Vienna Township Police Department, in violation of the Ohio Revised Code, Title 29, Section 2911.13(A)&(C), and against the peace and dignity of the State of Ohio.

COUNT 3: THEFT IN OFFICE (F4)

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 23rd day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, a public official or party official, did commit any theft offense, as defined in Division (K) of Section 2913.01 of the Revised Code, when MICHAEL PATRICK SHEEHY used his office in aid of committing the offense or permitted or assented to its use in aid of committing the offense, and/or the property or service involved is owned by this State, any other State, the United States, a county, a municipal corporation, a township, or any political subdivision, department, or agency of any of them, is owned by a political party, or is part of a political campaign fund, and the value of property or services stolen is \$1,000.00 or more and is less than \$7,500.00, to-wit: two firearms, in violation of the Ohio Revised Code, Title 29, Section 2921.41(A)(1)and/or(2)&(B), and against the peace and dignity of the State of Ohio.

COUNT 4: PETTY THEFT (M1)

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 28th day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, with purpose to deprive the owner of property or services, did knowingly obtain or exert control over the property or services, without the consent of the owner or person authorized to give consent, and/or beyond the scope of the express or implied consent of the owner or person authorized to give consent, to-wit: \$700.00 of U.S. Currency, in violation of the Ohio Revised Code, Title 29, Section 2913.02(A)(1)and/or(2)&(B)(1)(2), and against the peace and dignity of the State of Ohio.

COUNT 5: POSSESSING CRIMINAL TOOLS (M1)

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 28th day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, did possess or have under his control any substance, device, instrument, or article, with purpose to use it criminally, to-wit: a "slim jim", in violation of the Ohio Revised Code, Title 29, Section 2923.24(A)&(C), and against the peace and dignity of the State of Ohio.

COUNT 6: AGGRAVATED POSSESSION OF DRUGS (F5)

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 29th day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, did knowingly obtain, possess, or use Fentanyl, a Schedule II controlled substance, in violation of the Ohio Revised Code, Title 29, Section 2925.11(A)&(C)(1)(a), and against the peace and dignity of the State of Ohio.

You are hereby notified that you are under indictment for a felony offense involving the illegal possession, use, sale, administration, distribution, or trafficking in any drug of abuse; and pursuant to Section 2923.13 of the Ohio Revised Code, you are prohibited from acquiring, having, carrying, or using any firearm or dangerous ordnance while under indictment.

COUNT 7: GRAND THEFT (F3)


THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 23rd day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, with purpose to deprive the owner of property or services, did knowingly obtain or exert control over the property or services, without the consent of the owner or person authorized to give consent, and/or beyond the scope of the express or implied consent of the owner or person authorized to give consent, and the property stolen is a firearm or dangerous ordnance, in violation of the Ohio Revised Code, Title 29, Section 2913.02(A)(1)and/or(2)&(B)(4), and against the peace and dignity of the State of Ohio.

COUNT 8: THEFT IN OFFICE (F5)

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about the 28th day of January, 2019, at Trumbull County, Ohio, MICHAEL PATRICK SHEEHY, a public official or party official, did commit any theft offense, as defined in Division (K) of Section 2913.01 of the Revised Code, when MICHAEL PATRICK SHEEHY used his office in aid of committing the offense or permitted or assented to its use in aid of committing the offense, and/or the property or service involved is owned by this State, any other State, the United States, a county, a municipal corporation, a township, or any political subdivision, department, or agency of any of them, is owned by a political party, or is part of a political campaign fund, to-wit: a "slim-jim", in violation of the Ohio Revised Code, Title 29, Section 2921.41(A)(1)and/or(2)&(B), and against the peace and dignity of the State of Ohio.






